# Pairing a Bluetooth Device

❿

- 1. Turn on your Bluetooth device.
- 2. Power on Total PA Premier.

- Use the **Mode** button to select Bluetooth as the audio source, which appears as "bt" in the display. Total PA Premier will automatically go into pairing mode to search for Bluetooth devices. You will know you are in pairing mode when the Bluetooth icon is flashing. In addition, automatic voice prompts from the speaker will alert you of the device's status: Bluetooth Pairing, Bluetooth Connected, or Disconnected.
- Navigate to your Bluetooth device's setup screen, find Total PA Premier, and connect. The Bluetooth icon will remain solidly lit.
  - Note: Users should consider updating their device's OS if experiencing trouble with pairing or playing music.
- To disconnect pairing, turn off Bluetooth on your device or select Forget this device on your Bluetooth device's setup screen.

If you would like to disable (or enable) the voice prompts, press and hold the Play/Pause button on the Media Panel.

Note: Bluetooth must be selected as the audio source in order to disable (or enable) the voice prompts.

## App Control

IMPORTANT: To ensure the best possible experience with the app, use the most current Android OS or iOS on your device.

Note: Ensure that your device has internet access via your service provider or wireless connection. You can also download the app on your computer, but remember to connect and sync your device to transfer the app.

Follow these steps to download the free app on your device:

- 1. Open the Apple App Store or Google Play on your device.
- Search for the ION Sound XP app. 2.
- Follow the on-screen instructions to download and install the app.
- 4. Once downloaded, the ION Sound XP app will appear on your device's home screen.

#### **Automatic Power Shut-Off**

Total PA Premier is equipped with an automatic power shut-off to save energy in compliance with the energy efficiency regulations for compact audio products. Total PA Premier will enter an energy-saving mode after 20 minutes unless an audio signal at a moderate level is detected from the XLR Input, the Aux Input, the USB/SD media player, the Radio, or a Bluetooth connection. In energy-saving mode, the display and lights will turn off and audio playback will be disabled, but the unit will remain powered on in standby.

To resume normal operation, simply turn a knob or press a button on the unit or remote

To prevent automatic shut-off, an audio signal should remain active at a moderate volume level from the XLR Input, the Aux Input, the USB/SD media player, the Radio, or a Bluetooth connection. We recommend setting audio source (i.e., Aux Input or Bluetooth) volume at max and the Master Volume to 5 or higher to prevent shut-off.

#### Speaker Stand Installation

- Fully extend the speaker stand tripod legs on a flat, stable surface. Look in the box contents under the foam sheet for the rubber feet and speaker stand mounting knob.
- Raise the mounting pole up to the appropriate height needed and tighten the side
- Insert the pin into the bottom pin-hole so the mounting pole stays at your set height.
- On Total PA Premier, adjust the bottom knob counter-clockwise so the screw is not blocking the opening.
- Line up the Total PA Premier mounting hole with the speaker stand pole and place on the pole.
- Tighten the mounting knob clockwise on Total PA Premier.

### Linking Two Speakers

To wirelessly link two Total PA Premier speakers:

- Power on both speakers using their Power Switches.
- With no Bluetooth connected, press the Mode button on one Total PA Premier to select Bluetooth as the audio source, which appears as "bt" in the display. This will be the "secondary" speaker.
- Press the Link button on a second Total PA Premier to enter Stereo Link Mode. This will be the "primary" speaker.
- Wait up to 1 minute for the speakers to make the connection. Once the two speakers are linked, press the Mode button on the "primary" speaker to select the desired audio source. Use the directions above to connect your Bluetooth device.
- To disconnect, double-press the Link button on the "primary" speaker.

To link two Total PA Premier speakers using cables:

- With the Power Switch on each speaker turned to the off position, connect each speaker to a power outlet.
- Plug an XLR cable into the Mix Out located on the rear panel of one Total PA Premier speaker. This speaker (the primary) is the one to which you will connect audio sources such as a Bluetooth device, microphone, or USB flash drive.
- Plug the other end of the XLR cable into the XLR Input on the rear panel of your second Total PA Premier speaker. This second speaker will receive the audio from any devices connected to the first speaker (the primary).
- Power on both speakers using their Power Switches.
- Connect your audio sources to the first speaker (the primary).
- Make sure that each speaker's **Master Volume** control is set to the same position.
- With one of your audio sources playing, gradually turn up the Aux Input Volume on the second Total PA Premier speaker until the volume of this speaker matches the volume of the first speaker (the primary).

### **Light Modes**

Press the **Light Mode** button to toggle between five modes for the lights on the front panel:

- Color Wheel: The lights spin on and around the woofer.
- Color Wheel Beat Sync: The lights spin on and around the woofer according to the tempo of the music playing.
- Color Cycle: The lights steadily cycle through different colors.

#### **Product Warranty**

(for products purchased in the U.S.A.)

#### 1. What is covered and for how long?

All Products: ION Audio, LLC ("ION Audio") warrants to the original purchaser that ION Audio products and all other accessories are free from defects in material and workmanship under normal use and service for the period commencing upon the date of purchase from an authorized ION Audio dealer and continuing for the following period of time after that date for ninety (90) days. ION Audio warrants factory-refurbished merchandise to be free of material and operational defects for a period of ninety (90) days from the original date of retail sale. This refurbished merchandise warranty is not transferable.

- 2. What is not covered? This Limited Warranty is conditioned upon proper use of the product by the purchaser. This Limited Warranty does not cover: (a) damage caused by improper installation or improper connection to any peripheral; (b) damage caused by an external electrical fault; (c) large from use of parts not manufactured or sold by ION Audio; (d) product purchased from anyone other than an ION Audio authorized dealer; (e) modifications to product not approved in writing by ION Audio; (f) equipment that has the serial number removed or made illegible; (g) normal cosmetic and mechanical wear; (h) damage or loss during transit to an Authorized ION Audio Repair Center; or (i) units that are purchased and/or located outside of the continental USA.
- 3. What are ION Audio's obligations? During the applicable warranty period, ION Audio will repair or replace, at ION Audio's sole option, without charge to the purchaser, any defective component part of the product. To obtain service under this Limited Warranty, purchaser must first contact ION Audio and obtain a return merchant authorization ("RNA") number. Purchaser must then return the product to ION Audio in an adequate container for shipping, accompanied by purchaser's sales receipt or comparable proof of sale showing the date of purchase, the serial number of the product, and the seller's name and address. 
- A return merchant authorization number must be obtained from your local ION Audio representative. For

- The faulty equipment must be packed in its original packaging.
- One additional outer layer of packaging must be included to ensure product safety. Failure to do so may
  inadequately protect the equipment in transit and therefore jeopardize the warranty.
- ION Audio will not accept COD shipments and no call tags will be issued for merchandise return.
- ION Audio will not return repaired merchandise to customers by priority service except by written request
  at the customer's cost. Requests must be submitted in writing with returned merchandise.
- The defective ION Audio equipment should be sent freight prepaid with the return merchant authorization number printed clearly on the outer packaging and original sales receipt enclosed to your local service center.


### **Important Safety Instructions**
